ADVERTISEMENT FOR FILLING UP OF POSTS OF JUNIOR RESIDENTS IN
P.R.M MCH, BARIPADA.

Eligible candidates are invited for Walk-In Interview for Selection to the Posts of Junior Resident in P.R.M MCH, Baripada on contractual basis. The applicant must have acquired the required qualification for the post applied for, on or before the date of interview. The engagement shall be purely temporary for a period of one year which may be extended on year-to-year tenure basis and maybe for a maximum period of three years subject to requirement and satisfactory performance. The posts are non-practicing. The candidates will be paid consolidated amount of Rs.60,000/- (Rupees Sixty thousand only) per month. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable. Eligibility of application will be guided as per the provisions mentioned here under:

1. Available vacancy: 29 Posts

N:B- The above vacancy may be very from time to time.

2. Age: Must be less than 70 years.(as on date of interview)

4. Eligibility and Qualifications for Junior Residents:

i. Qualification:

- i. A candidate must possess a MBBS degree (for medical stream) or equivalent degree from a recognized by MCI/NMC/DCI or as the case may be notify MCI/NMC/DCI from time to time in force.
- ii. The candidate must have completed the compulsory one-year rotating internship.
- iii. The above qualifications must have been obtained on or before the date of interview.

ii. Other Eligibility Conditions:

- i. The candidate must be a citizen of India.
- ii. The candidates must have registered their Medical Qualification at Central/ State Medical Council/ Dental Council.(Permanent Registration)
- iii. Candidates having post-graduation in any discipline or are continuing / have completed tenure as Junior Resident/Senior Resident/Tutor in any Govt. Medical colleges of the state are not eligible to apply.
- iv. Candidates who are serving under OMHS cadre on regular basis are not eligible to apply.

5. Procedure for Application:

Candidates shall download the Application Form annexed in this Advertisement (Page 4 and 5) from www.prmch.nic.in and come for the Interview with duly filled in Application Form and all requisite original documents. They have to come with a Demand Draft of Rs. 500/- in favor of “**Dean & Principal, PRMMCH, Baripada**”, payable at Baripada towards application fees. The application fees is not refundable at any circumstances.

6. Procedure of Interview:

a. The candidate shall have to appear in person before the undersigned on **12.02.2024 at 10.00 A.M in the Office of Dean & Principal, PRM MCH, Baripada** along with the following documents:

- I. Application Form—duly filled up
- II. One passport size recent color photograph signed by the candidate at front to be pasted on the application form.
- III. Demand Draft of Rs.500/-
- IV. All Original Documents
- V. Self-attested Photocopies of-
 - i. H.S.C./Equivalent Certificate in support of age;
 - ii. +2 Science/ Equivalent Examination Certificate;
 - iii. MBBS Pass Certificate
 - iv. Mark Sheets in support of all the aforesaid examinations
 - v. Chance Certificate
 - vi. Internship Completion Certificate
 - vii. Certificate of Medical Registration(valid)
 - viii. Valid Photo ID Card issued by Govt. Authority (Passport/ Adhaar Card/PAN Card/ Voter ID Card)

b. There will be Document Verification and Interview by the Selection Committee based upon which candidates will be selected. At the time of document verification, physical presence of the candidate is mandatory and no authorization will be entertained.

7. Selection of Candidates:

- i. After successful verification of the documents, a Provisional Merit List shall be prepared and notified in the website on 13.02.2024 by 2 P.M.
- ii. The grievances from the candidates, if any, will be allowed to be put forth to the Email jrpmch2023@gmail.com between 2 P.M. to 5 P.M. of 13.02.2024.
- iii. The Final Merit List will be notified and Engagement Order will be uploaded in the website.
- iv. The Candidate can join immediately within 7 days from issuing the joining order.
- v. In case, the candidate does not join, the next candidates in the Merit List will be allowed to join in The same post.
- vi. The final merit list will remain valid for a period of one year or till subsequent advertisement whichever is earlier. Any other related information/ changes if required shall be notified by the undersigned in the website www.prmch.nic.in. All communication shall be made through the website of PRM MCH Baripada.(No Postal/personal communication will be made).

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary/legal action as deemed proper will be initiated against him/her.

8. Selection Process:

- i. Selection will be strictly on the basis of merit list prepared on basis of career marks. Weight age for different examinations shall be as under:
HSC/Matriculation- 20% of total percentage of marks secured.
Intermediate Science-20% of total percentage of marks secured.
MBBS examination-60% of total percentage of marks secured.
- ii. One percentage mark will be deducted for each extra chance in the concerned subject while calculating aggregate percentage of MBBS.
- iii. In case of foreign medical graduates (FMGE) the marks secured in the subjects as per the **NMC/MCI /DCI** conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such mark sheet, their marks will be taken as 50%.
- iv. In case of tie, it will be resolved as follows:
 - i. "The candidate securing more marking MBBS shall be placed in higher rank.
 - ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger."
- v. Engagement will be made on the basis of the choice of Institution/Subject exercised by counseling on personal appearance.

9. Terms and Conditions:

The terms and conditions as stipulated in the Govt. Guidelines issued from time to time in force will be followed.
