Eligible candidates are invited to attend the Walk-in-Interview for the post of Assistant Professors in PRM MCH, BARIPADA on contractual/deputation basis in view of MCI/NMC urgency. The details of eligibility criteria/ vacancies/ etc.are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis for a maximum period of four years. The candidates who are continuing as faculties in any of the Govt. Medical College of the state, VIMSAR, Burla or AHPGIC, Cuttack, either on contractual / deputation are not eligible to apply. The regular candidates under OMES cadre are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years.

### 4. Eligibility and Qualifications for Assistant Professor:

- i) The candidate must be a citizen of India.
- ii) The candidate must possess MD/ MS degree in the concerned discipline from any MCI/NMC approved/ recognized/ permitted Medical Colleges or any other academic qualification with such additional teaching experience in the subject as may be prescribed by the NMC and as per "Teachers Eligibility Qualifications in Medical Institutions Regulations,2022" of NMC as amended from time to time. Candidates having M.Sc. (medical Subjects) in pre & para clinical subjects (approved by NMC/MCI) may be considered if sufficient candidates with PG degree/DNB are not available and Subject to the limitations as may be prescribed by NMC/MCI from time

- iii) The Medical graduates must have registered himself/ herself under any State Medical CouncilMCI/NMC after obtaining the degree(permanent Registration). iv)
- The above qualifications must have been obtained on or before the date of counseling/interview.

## 5. Procedure for Application:

#### 8. Selection Process:

i. Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:

HSC/Matriculation- 20% of total percentage of marks secured. Intermediate Science-20% of total percentage of marks secured. MBBS examination-60% of total percentage of marks secured.

In case of candidates who have passed PG in 2016-17 and afterwards, MBBS/ M.Sc. Examination-30%, PG-30%

- ii. One mark will be deducted from the total Career Mark for each extra chance taken to pass the examination.
- iii. In case of tie, it will be resolved as follows:
  - i. "The candidate securing more mark MBBS//M.Sc shall be placed in higher rank.
  - ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger."

#### 9. TERMSANDCONDITIONS

All the terms and conditions as per Govt. letters issued from time to time shall be applicable.

- a. The Direct Assistant Professors are entitled for remuneration of Rs. 1,20,000/per month, In addition to the above, any incentive as may be notified by the
  Govt. shall be allowed.
- b. The in-service candidates shall be allowed salary as per to the post in which appointed and any incentive as may be notified by Govt. It will be guided as per the Govt. letters issued from time to time.
- c. The engagement shall be purely temporary and on year-to-year tenure basis and

may be for a maximum period of four years subject to satisfactory performance. However, the Govt. reserves the right to terminate the services of the faculty with one- month prior notice from either side.

d. Selected candidates have to sign an agreement as per Govt. resolution 8967/H&FW Dt. 25.4.2022.
