ADVERTISEMENT FOR FILLING UP OF POSTS OF ASSISTANT PROFESSOR
IN PRM MCH, BARIPADA.

Eligible candidates are invited to attend the Walk-in-Interview for the post of Assistant Professors in PRM MCH, BARIPADA on contractual/deputation basis in view of MCI/NMC urgency. The details of eligibility criteria/ vacancies/ etc. are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis for a maximum period of four years. The candidates who are continuing as faculties in any of the Govt. Medical College of the state, VIMSAR, Burla or AHPGIC, Cuttack, either on contractual / deputation are not eligible to apply. The regular candidates under OMES cadre are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years.

4. **Eligibility and Qualifications for Assistant Professor:**

- i) The candidate must be a citizen of India.
- ii) The candidate must possess MD/ MS degree in the concerned discipline from any MCI/NMC approved/ recognized/ permitted Medical Colleges or any other academic qualification with such additional teaching experience in the subject as may be prescribed by the NMC and as per "Teachers Eligibility Qualifications in Medical Institutions Regulations, 2022" of NMC as amended from time to time. Candidates having M.Sc. (medical Subjects) in pre & para clinical subjects (approved by NMC/MCI) may be considered if sufficient candidates with PG degree/DNB are not available and Subject to the limitations as may be prescribed by NMC/MCI from time

to time. The candidates having DM/M.Ch/ DNB or equivalent degree are not required any additional teaching experience.

- iii) The Medical graduates must have registered himself/ herself under any State Medical Council/MCI/NMC after obtaining the degree(permanent Registration).
- iv) The above qualifications must have been obtained on or before the date of counseling/ interview.

5. Procedure for Application:

Candidates shall download the Application Form annexed in this Advertisement (Page 6 and 7) from www.prmch.nic.in and come for the Interview with duly filled in Application form with all requisite original documents. They have to come with a Demand Draft of Rs. 500/- in favor of **“Dean & Principal, PRMMCH, Baripada”**, payable at Baripada towards application fees. The application fees is not refundable at any circumstances.

6. Procedure of Interview:

- i.) The candidate shall have to appear in person before the undersigned on **12.08.2024 at 10.30 A.M in the Office of Dean & Principal, PRM MCH, Baripada** along with the following documents:
Self-attested photocopy of:
 - a. Demand Draft of Rs.500/-.
 - b. One passport size recent colour photograph signed by the candidate at front to be pasted on the application form.
 - c. H.S.C./ Equivalent Certificate in support of age;
 - d. +2/ Equivalent Examination Certificate;
 - e. MBBS/MD/MS/DNB/ Pass Certificate;
 - f. Mark sheets in support of all the aforesaid examinations (i.e. from H.S.C. onwards) passed including fail marks.
 - g. Chance Certificate of MBBS/MD/MS/DNB.
 - h. Valid Certificate of Medical Registration from State Medical Council (Both UG & PG);
 - i. Teaching Experience certificate from Competent Authority Service Certificate if in service.
 - j. No Objection Certificate from Non-Odisha Govt. Employer/Authority
 - k. Valid Photo ID issued by the Govt. authorities i.e. Passport/PANCard/Voter I card/AADHAR card.
 - l. If a candidate claims to possess qualification equivalent to the prescribed qualification, the rule/ authority (with number and date) under which it is so treated must be furnished with the application form.
- ii) There will be Document Verification and Interview by the Selection Committee based upon which candidates will be selected. At the time of document verification, physical presence of the candidate is mandatory and no authorization will be entertained.

7. Selection of Candidates:

- i) After successful verification of the documents, a Provisional Merit List shall be

- prepared and notified in the website on **13.08.2024 by 2 P.M.**
- ii. The grievances from the candidates, if any, will be allowed to be put forth to the Email **irprmmch2023@gmail.com** between **2 P.M. to 5 P.M. of 14.08.2024.**
 - iii. The Final Merit List will be notified and Engagement Order will be uploaded in the website.
 - iv. The Candidate can join immediately within 7days from issuing the joining order.
 - v. In case, the candidate does not join, the next candidates in the Merit List will be allowed to join in the same post.
 - vi. The final merit list will remain valid for a period of one year or till subsequent advertisement whichever is earlier. Any other related information/ changes if required shall be notified by the undersigned in the website **www.prmch.nic.in.** All communication shall be made through the website of PRM MCH Baripada.(No Postal/personal communication will be made).

N.B.: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary/legal action as deemed proper will be initiated against him/her.

8. Selection Process:

- i. Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:
HSC/Matriculation- 20% of total percentage of marks secured.
Intermediate Science-20% of total percentage of marks secured.
MBBS examination-60% of total percentage of marks secured.
- In case of candidates who have passed PG in 2016-17 and afterwards, MBBS/ M.Sc. Examination-30%,PG-30%
- ii. One mark will be deducted from the total Career Mark for each extra chance taken to pass the examination.
 - iii. In case of tie, it will be resolved as follows:
 - i. "The candidate securing more mark MBBS/ /M.Sc shall be placed in higher rank.
 - ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger."


9. TERMSANDCONDITIONS

All the terms and conditions as per Govt. letters issued from time to time shall be applicable.

- a. The Direct Assistant Professors are entitled for remuneration of Rs. 1,20,000/- per month, In addition to the above, any incentive as may be notified by the Govt. shall be allowed.
- b. The in-service candidates shall be allowed salary as per to the post in which appointed and any incentive as may be notified by Govt. It will be guided as per the Govt. letters issued from time to time.
- c. The engagement shall be purely temporary and on year-to-year tenure basis and

may be for a maximum period of four years subject to satisfactory performance. However, the Govt. reserves the right to terminate the services of the faculty with one- month prior notice from either side.

- d. Selected candidates have to sign an agreement as per Govt. resolution 8967/H&FW Dt. 25.4.2022.
- e. The candidates who, after being selected, do not join or leave the job without prior notice of one month shall not be considered for subsequent advertisements for three years.
