**ADVERTISEMENT FOR FILLING UP OF POSTS OF ASSOCIATE
PROFESSOR IN PRM MCH, BARIPADA.**

Eligible candidates are invited to attend the Walk-in-Interview for the post of Associate Professors in **PRM MCH, BARIPADA** on contractual/deputation basis in view of MCI/DCI/NMC urgency. The details of eligibility criteria/ vacancies/ etc. are as under. The direct candidates shall be appointed on contractual basis and the in-service candidates shall be appointed on deputation basis for a maximum period of four years. The candidates who are continuing as faculties in any of the Govt. Medical College of the state, VIMSAR , Burla or AHPGIC, Cuttack , either on contractual / deputation are not eligible to apply. The regular candidates under OMES cadre are not eligible to apply. The faculties whose tenure is terminated for any reason by the appointing authority will be debarred from being selected for a period of next three years.

4. **Eligibility and Qualifications for Associate Professor:**

- i) The candidate must be a citizen of India.
- ii) Must have possessed MD/MS/MDS/DNB or equivalent degree in the concerned specialty. In case of non availability of candidates in Anatomy, Physiology & Biochemistry the candidates with medical M.Sc. qualification with Ph. D may be considered or as per Teachers Eligibility Qualifications (TEQ, 2022) of NMC and its amendment and OMES rule 2021. Must have teaching experience of minimum 4 years as Assistant Professor in the concerned discipline in any MCI/ DCI/NMC

permitted / recognized institute with research publications as per MCI/DCI/NMC guidelines / OMES rule 2021 in force.

- iii) Must have valid up to date medical registration along with registration of additional qualification under any State Council of Medical/Dental after obtaining the degree.
- iv) Must have completed basic course in medical education from institution designated by NMC/DCI.
- v) Must have completed basic course in Bio-Medical Research.

5. Procedure for Application:

Candidates shall download the Application Form annexed in this Advertisement (Page 5 and 6) from www.prmch.nic.in and come for the Interview with duly filled in Application form with all requisite original documents. They have to come with a Demand Draft of Rs. 500/- in favor of **“Dean & Principal, PRMMCH, Baripada”**, payable at Baripada towards application fees. The application fees is not refundable at any circumstances.

6. Procedure of Interview:

i.) The candidate shall have to appear in person before the undersigned on **13.01.2025 at 11.30 P.M in the Office of Dean &Principal, PRM MCH, Baripada** along with the following documents:

Self-attested photocopy of:

- i. Application form duly filled in.
- ii. Bank receipt for online deposit of Rs.500/-.
- iii. H.S.C./Equivalent Certificate in support of age;
- iv. +2/Equivalent Examination Certificate;
- v. MBBS/MD/MS/MDS/DNB/M.Sc with PhD Pass Certificate;
- vi. Mark sheets in support of all the afore said examinations (i.e. from H.S.C. onwards) passed including fail marks if any.
- vii. Certificate of Registration for Medical Qualifications from Odisha Council of Medical Registration (valid up to date for UG &PG);
- viii. Chance Certificate of MBBS/MD/MS/MDS/DNB/MSc is mandatory.
- ix. Teaching Experience certificate from Competent Authority.
- x. No Objection Certificate from Non Odisha Govt. Employer /Authority
- xi. Photo ID issued by the Govt. authorities i.e. Passport/PAN Card/Voter I card/, AADHAAR card
- xii. a) If a candidate claims to possess qualification equivalent to the prescribed qualification, the rule/ authority (with number and date) under which it is so treated must be furnished with the application form.

b) There will be Document Verification and Interview by the Selection Committee based upon which candidates will be selected. At the time of document verification, physical presence of the candidate is mandatory and no authorization will be entertained.

7. Selection of Candidates:

- i) After successful verification of the documents, a Provisional Merit List shall be prepared and notified in the website on **16.01.2025 by 2 P.M.**
- ii. The grievances from the candidates, if any, will be allowed to be put forth to the Email **jrprmmch2023@gmail.com** between **2 P.M. to 5 P.M. of 17.01.2025.**
- iii. The Final Merit List will be notified and Engagement Order will be uploaded in the website.
- iv The direct candidates must report before the authority of the institution allotted within seven days of issue of engagement order or as may be instructed in the appointment order and the in-service candidates shall join after obtaining the relieve order from Government.
- v. In case, the candidate does not join, the next candidates in the Merit List will be allowed to join in the same post.
- vi. The final merit list will remain valid for a period of one year or till subsequent advertisement whichever is earlier. Any other related information/ changes if required shall be notified by the undersigned in the website **www.prmch.nic.in.** All Communication shall be made through the website of PRM MCH Baripada. (No Postal/personal communication will be made).

N.B. : In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/her application shall be rejected and disciplinary/legal action as deemed proper will be initiated against him/her.

8.) Selection Process:


- a. Selection will be strictly on the basis of merit list prepared on basis of teaching experience, research publications and age of the candidate:-
 - i. Weightage for teaching experience: 5 marks per year of experience as Asst. Professor/ Assoc. Professor from MCI/DCI/NMC/ permitted or recognized institutions.
 - ii. Weightage for research publications: 5 marks per publication; (publication as per norm of NMC/DCI shall be considered).
- b. In case of tie, it will be resolved as follows:
 - i. In case of tie the elderly, candidates shall be placed higher in rank to the younger.”
- c. The Selection Authority at their discretion may short-list the merit list to a reasonable number as per available vacancy.

- d. In case the candidate appointed to a post, fails to join in time, then the next candidate in the panel for the subject may be given a chance.

9.) **TERMS AND CONDITIONS**

All the terms and conditions as per Govt. letter issued from time to time shall be applicable.

- a. The Contractual (Direct) Associate Professors are entitled for remuneration of Rs. 2,00,000/- per month. In addition to the above, any incentive as may be notified by the Govt. time to time shall be allowed.
- b. The in-service candidates shall be allowed salary as par to the post in which appointed and any incentive as may be notified by Govt. It will be guided as per the Govt. letter No. 9684/H Dt. 02.05.2022.
- c. For contractual direct candidates, the engagement shall be purely temporary and on year-to-year tenure basis and may be for a period of maximum four years subject to satisfactory performance. However, the Govt. reserves the right to terminate the services of the faculty with one month prior notice from either side.
- d. Selected candidates have to register themselves in Odisha Council of Medical/Dental Registration within one month and sign an agreement as per Govt. resolution 8967/H&FW Dt. 25.4.2022.
- e. The candidates who, after being selected, do not join or leave the job without prior notice of one month shall not be considered for subsequent advertisements for three years.
